Check-in and Boarding Times:

[Web Check-in](#) is available for all flights from 24 hours prior to and up to 3 hours prior to the scheduled departure.

Airport Check-in Times:

- Caracas, Venezuela: 3 hours prior to, with closure 2 hours to the scheduled departure time.
- Other International: 3 hours prior to, with closure 1 hour prior to the scheduled departure time.
- Domestic: 2 hours prior to, with closure 1 hour prior to the scheduled departure time.

Boarding: Starts just after airport check-in closes.

Baggage Policy

Carry-On Allowances: Each customer is allowed not more than 1 carry-on item + 1 personal item, including duty free purchases. Both your carry-on item and your personal item must completely fit under the seat in front of you or in the overhead compartment. Carry-on item maximum weight 10kg or 22lb and total maximum dimensions (L+W+H) 114cm or 45in. Personal item total maximum dimensions (L+W+H) 91cm or 36in.

Checked Baggage Allowance: Each customer will be allowed a maximum of four checked bags. Your free baggage allowance is determined by your fare, destination and frequent flyer tier status. Any bag exceeding your free allowance is subject to space availability. The maximum weight for each checked bag is 23kg / 50lb and total linear dimensions (L+W+H) is 157cm(62in). **Extra, Heavy or Oversized checked bags** are subject to fees. These fees are per one-way travel and independent, i.e. an extra carry-on bag that is heavy and oversized will attract a combination of each fee.

Caribbean Miles members in Executive Gold, Gold, and Silver tiers travelling on all routes in economy class will be permitted 2 free checked bags up to 23kg (50lb) each.

Notice of Contract Terms

Notice of Incorporated Terms - The terms of the contract of carriage as set forth in carrier's tariffs on file with the U.S. Department of Transportation and the Canadian Transportation Agency and the [Conditions of Carriage](#) as set forth in full on carrier's website are hereby incorporated by reference and are made a part of this contract. You may inspect the full text of each term incorporated by reference at carrier's airport or city ticket offices, and you have the right, upon request at any location where carrier's tickets are sold within the United States, to receive free of charge by mail or other delivery service the full text of each such incorporated term.

The incorporated terms may include and passengers may obtain from any location where carrier's tickets are sold within the United States further information concerning:

- a) Limits on carrier's liability for personal injury or death of passengers, and for loss, damage, or delay of goods and baggage, including fragile or perishable goods;
- b) Claim restrictions, including time periods within which passengers must file a claim or bring an action against the carrier for its acts or omissions or those of its agents;
- c) Rights of the carrier to change terms of the contract;
- d) Rules about reconfirmation of reservations, check-in times, and refusal to carry;
- e) Rights of carrier and limitations concerning delay or failure to perform service, including schedule changes, substitution of alternate air carrier or aircraft, and rerouting.

Notice of Overbooking of Flights - Airline flights may be overbooked, and there is a slight chance that a seat will not be available on a flight for which a person has a confirmed reservation. If the flight is overbooked, no one will be denied a seat until airline personnel first ask for volunteers willing to give up their reservation in exchange for a payment of the airline's choosing. If there

are not enough volunteers the airline will deny boarding to other persons in accordance with its particular boarding priority. With few exceptions, persons denied boarding involuntarily is entitled to compensation. **To be eligible for compensation, customers must have presented themselves at the airport for check-in at least two (2) hours before departure of the international flight. Check-in means face-to-face interaction with an airline representative at the check-in counter.**

Advice to Passenger on limitation of Liability - Passengers on a journey involving an ultimate destination or a stop in a country other than the country of origin are advised that the provisions of the Warsaw Convention or the Montreal Convention as appropriate may be applicable to the entire journey, including any portion entirely within the country of origin or destination. The applicable treaty governs and may limit the liability of carriers to passengers for death or personal injury, destruction or loss of, or damage to, baggage, and for delay of passengers and baggage.

Additional protection can usually be obtained by purchasing insurance from a private company. Such insurance is not affected by any limitation of the carrier's liability under an international treaty. For further information please consult your airline or insurance company representative.

Dangerous Articles - It is illegal to carry dangerous goods - that means anything that poses a significant threat to health, safety or property when transported by air - in your checked baggage or hand baggage. Dangerous goods include explosives (flares, fireworks, ammunition, certain chemicals, power rivets, etc.); gases (aerosols containing toxic, flammable and/or explosive substances, butane cylinders, breathing apparatus); flammable liquids and materials (paints, lacquers, polish, filters, adhesives, lighter fluids, matches); household cleaners (bleaches, ammonia, corrosive substances, items such as car and wheelchair batteries); pesticides and other toxic substances; swimming pool chemicals and other oxidizing substances; and magnetized materials. Read the warning labels on items before packing your bags, and check with CARIBBEAN AIRLINES Cargo Division if you wish to transport any dangerous goods as cargo. Transport of explosives or munitions of war as cargo requires the approval of the Ministry of Works and Transport in Trinidad and Tobago.
